# APPLICATION TO OPERATE FOR SECTORS APPROVED BY THE GOVERNMENT DURING THE MOVEMENT CONTROL ORDER FOR THE PERIOD OF 1 JUNE TO 14 JUNE 2021 VIA CIMS 3.0 PORTAL

The National Security Council (MKN) meeting today had concluded for the approval of companies under the economic sectors allowed to operate by the Government during the Movement Control Order (MCO) commencing 1 June until 14 June 2021 to be obtained via the **COVID-19 Intelligent Management System (CIMS) 3.0** managed by the Ministry of International Trade and Industry (MITI).

Therefore, all economic sectors listed below may access the CIMS 3.0 portal to obtain a letter of approval to operate, if they have yet to receive approval to operate from 1 June 2021, through **notification.miti.gov.my**:

- i. Manufacturing and Manufacturing-related Service-MRS;
- ii. Distributive trade including wholesale, retail and distribution;
- iii. Food and beverages including for animals
- iv. Health and medical care including dietary supplements, animal care and clinics as well as veterinary services;
- v. Communications including media, telecommunications and internet, post and courier as well as broadcasting (for the purpose of conveying information, news and related activities);
- vi. E-commerce and information technology;
- vii. Production, distillation, storage, supply and distribution of fuels and lubricants; and
- viii. Critical construction, maintenance and repair.



Companies that are already registered in CIMS 3.0 are not required to re-apply and can proceed to download the approval letter to operate starting 8.00 pm, May 31, 2021. For companies that have yet to register, can submit their application from 8.00 am, 1 June 2021. Detailed information on the registration procedure in CIMS 3.0 (via the notification.miti.gov.my link) can be accessed through www.miti.gov.my.

With this latest development, the movement of workers for these sectors can be supported with :

- i. CIMS 3.0 letter from MITI; and
- ii. Letter of employment from the employer OR employee pass.

MITI together with the Ministries and Agencies involved are committed to facilitate the application approval for the sectors announced by the Government.
